Dear Customer:

The New Jersey Department of Environmental Protection Pesticide Control Program requires us to provide customers with information about the materials that we will be using as part of the pest control program for your property. We are using this *Consumer Information Notice* to provide you with this information.

Sanitation, as well as physical and biological control measures, should be considered as part of a good pest control program. Pesticides may be used as another part of a good pest control program. Pesticides are substances used to control living organisms and vary in degree of toxicity.

We may apply the pesticides listed below to your property as part of your pest management program. The exact dates of application shall be made available to you if you request it. Additionally, you can find copies on the website or you may request a copy of the label for each pesticide that we will use. In certain cases, we will provide you label precautions relating to resident or general public safety to follow prior to and/or following application of individual pesticides. Instructions and precautions for all above listed products are:

“KEEP ALL PEOPLE AND PETS OUT OF THE TREATED AREA UNTIL DRY”

The sign(s) must remain in place for at least 72 hours following the application and we are responsible for removing the sign within 72 hours following application. We would appreciate it if you would remove the signs for us.
